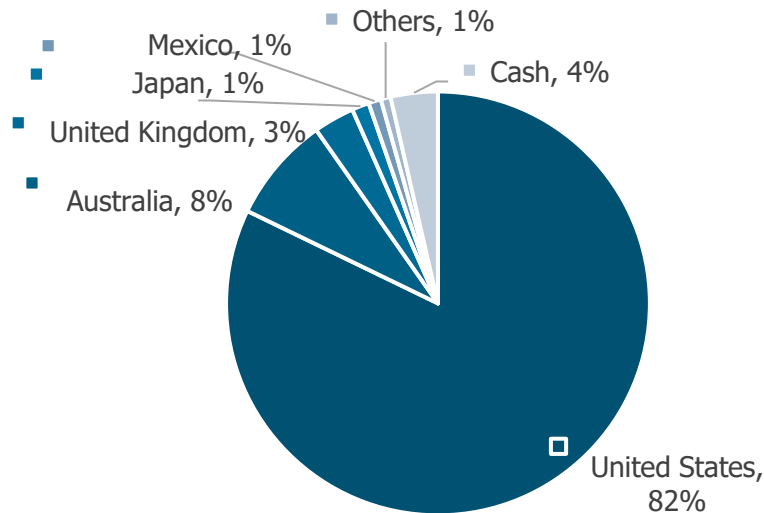
STRATEGY

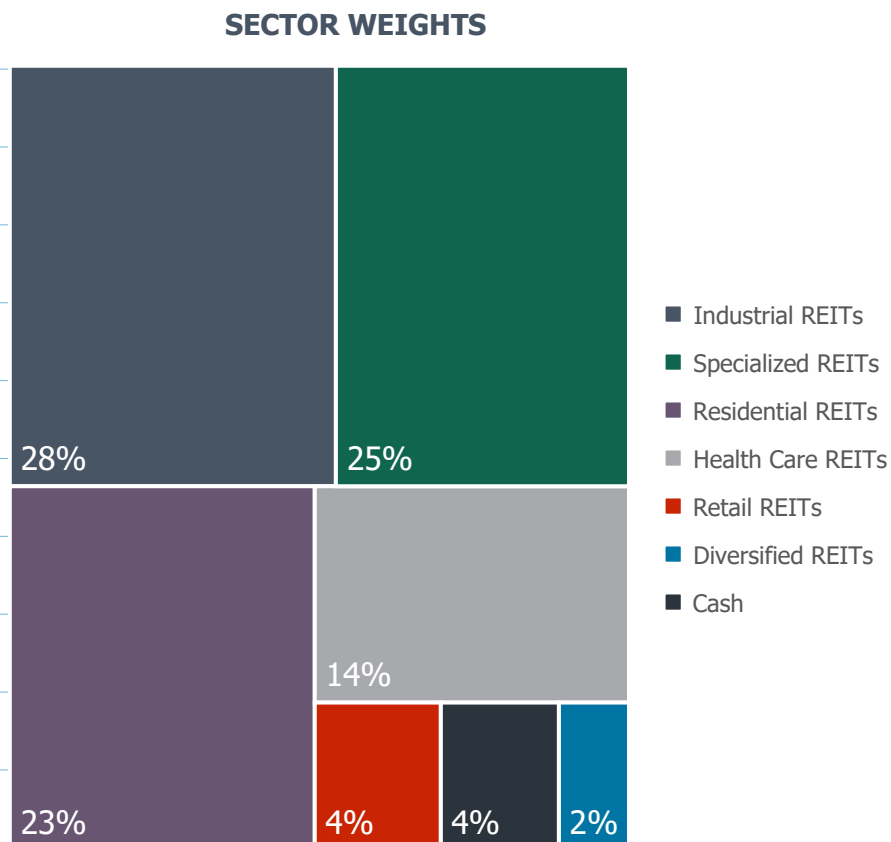
